As it is not weighted by geographic area and uses an exclusively postal methodology, the 2006 BVPI Borough-level result is not directly comparable with the 2005 YYC survey or the 2006 Citizen's Panel conducted just prior to the BVPI survey. Nevertheless, closer examination of area-committee level results that takes mode effects into account may suggest recent drops in neighbourhood satisfaction in Failsworth and Hollinwood, and in Saddleworth and Lees. The BVPI does not provide ward level data, so 'narrowing the gap' data will not become available until the repeat of the YYC survey in 2008. <b>Risk Analysis:</b> <b>Interventions Recommended:</b> <b>Interventions/Projects Current:</b> The Encams project is currently running in parts of Werneth and will address issues identified as environmental priorities in a small-scale survey of Werneth residents (litter and fly-tipping). Werneth is located in West Oldham, the Area Committee with the lowest overall neighbourhoodsatisfaction.	<b>Responsibility - Bruce Penhale (Adele Small)</b> <b>Comments on Performance:</b> The figure is taken from the October 2006 Citizen's Panel recruitment questionnaire, a survey of 1700 people. Ward level data is not available through this survey and direct comparison with the 2005 You and Your Community survey is problematic due to methodological differences. The leading cause of dissatisfaction with neighbourhood identified in the Citizen's Panel was 'area dirty / too much litter' (21% of dissatisfied respondents). Secondary analysis of the 2005 You and Your Community survey shows clear differences in neighbourhood satisfaction between HMR residents and non-HMR residents. As expected, proportionally fewer HMR residents (60%) than non-HMR residents (75%) are satisfied with their neighbourhood as a place to live. <b>Risk Analysis:</b> <b>Interventions Recommended:</b> <b>Interventions/Projects Current:</b>

Analysis shows a reduction in violent crime offences, but a slight increase in vehicle crime and criminal damage. However, further analysis of criminal damage offences shows that the slight increase in damage figures is down to a substantial rise in damage other offset against a substantial decrease in damage to vehicles. <b>Risk Analysis:</b> Not achieved the target. <b>Interventions Recommended:</b> Thematic and geographic profiles have been produced. This will enable the targeting of hotspot areas in the priority wards to take place together with emerging geographic areas. A Strategic Assessment (2007) is currently being produced which will assist further in the delivery process. <b>Interventions/Projects Current:</b> A number of interventions are currently in place in priority areas through the work of the Area Action Teams. Evaluation of these interventions will assist the Strategic Assessment process and the formulating of a new Opportunity Strategy. Current projects involved the fitting of Alley Gates, the erection of CCTV systems linked to crime problems and target hardening of properties.	<b>Responsibility - Colin Cooper</b> <b>Comments on Performance:</b> There has been an increase in the number of comparator crimes in Q3 compared to Q2. Analysis shows that whilst vehicle crime and violent crime maintain a downward trend, the number of incidences of criminal damage, especially to motor vehicles, has increased substantially and total damage offences, including arson, now accounts for over 44% of comparator crime offences (excluding burglary). <b>Risk Analysis:</b> It is unlikely that we will achieve our target for 2006/2007 with an end of year projection of over 15,000 crimes against a target of 13,659 crimes. <b>Interventions Recommended:</b> Whilst thematic profiles have been produced for domestic burglary and vehicle crime the thematic profile for criminal damage has not yet been completed. Once this profile has been completed it will enable resources to be deployed accordingly. <b>Interventions/Projects Current:</b> A number of interventions are currently in place in priority areas through the work of the Area Action Teams. Evaluation of these interventions will assist when the thematic and geographic profiles are produced. Current projects involved the fitting of Alley Gates, the erection of CCTV systems linked to crime problems and target hardening of properties.

However further analysis shows that the current trend is downwards. Extensive work by the police in targeting prolific offenders towards the end of the quarter has had an impact in reducing the number of domestic burglaries particularly in March. <b>Risk Analysis:</b> Target not achieved but positive action has resulted in minimising the effect. <b>Interventions Recommended:</b> A domestic burglary profile has been produced along with geographic profiles in the priority areas. This has assisted in reducing burglary offences in March. The information is still relevant and will assist in resource deployment into 2007/2008. A new Strategic Assessment is currently being produced which will assist further. <b>Interventions/Projects Current:</b> A number of burglary project are currently ongoing, especially within the priority areas. These involved the fitting of alley gates, the target hardening of vulnerable properties, especially repeat victims and the targeting of prolific juvenile offenders.	<b>Responsibility - Colin Cooper</b> <b>Comments on Performance:</b> There has been an increase in the number of domestic burglary offences in Q3 compared to Q2 and the current trend is upwards with a projected end of year total in excess of 2300 against a LAA target of 2013. Analysis of the data suggests that 21% of all domestic burglaries are recorded as attempts and 27% are recorded as the result of an insecurity. The number of attempts has increased 3.3% year on year whilst the number of insecurities has increased 1.4% year on year. The top four wards for domestic burglary are Alexandra (Holts Estate), Waterhead (Clarksfield), Medlock Vale (Coppice) and St. Mary's. <b>Risk Analysis:</b> Given the increase in domestic burglary in Q3 and the current upward trend it is unlikely that we will achieve our LAA target in 2006/2007 <b>Interventions Recommended:</b> A domestic burglary profile has been produced along with geographic profiles in the priority areas. This will enable resources to be deployed in Q4 to minimise the rise in burglary offences and address the trend. <b>Interventions/Projects Current:</b> A number of burglary project are currently ongoing, especially within the priority areas. These involved the fitting of alley gates, the target hardening of vulnerable properties, especially repeat victims and the targeting of prolific juvenile offenders.

Analysis shows that the increase is due to a rise in theft from motor vehicle. However theft of motor vehicle has shown a decrease compared to Q3. Further analysis shows that vehicle crime is a particular problem in the Coldhurst ward, amounting to over 30% of crime. <b>Risk Analysis:</b> Target not achieved <b>Interventions Recommended:</b> A vehicle crime thematic profile has been written together with 5 priority ward profiles supported by an intervention plan. This will enable resources to be target appropriately in the first quarter of 2007/2008. <b>Interventions/Projects Current:</b> A number of crime preventative initiatives took place in Q4 involving awareness raising at a number of retail outlets and the targetting of hotspot locations, this will continue in Q1 2007/2008.	<b>Responsibility - Colin Cooper</b> <b>Comments on Performance:</b> The reduction in vehicle crime has continued in Q3 and the current trend is downward. Analysis shows that there has been a 33% increase in theft from a vehicle and a 9% decrease in theft of motor vehicle in 2006/2007 (April - December) compared to the same period in 2005/2006. Further analysis shows that whilst theft of motor vehicle offences have changed little quarter on quarter, there has been a substantial decrease in theft from vehicle offences in Q3 compared to Q1. <b>Risk Analysis:</b> Even though we have further reduced vehicle crime in Quarter 3, given our performance earlier in the year, it is unlikely that we shall meet our target for the year. Current end of year projections suggesting vehicle crime offences will exceed 4000 crimes against a target of 2993. <b>Interventions Recommended:</b> A vehicle crime thematic profile has been written together with 5 priority ward profiles supported by an intervention plan. This enabled resources to be target appropriately in Q3 and this will continue into Q4. <b>Interventions/Projects Current:</b> During both Q2 & Q3 a number of crime preventative initiatives took place involving awareness raising at a number of retail outlets and the targetting of hotspot locations.

Further analysis shows that during Q4 on average, 25% of violence against the person offences were domestic abuse related and reflects the positive action by GMP at DV incidents. Violent crime accounts for 16% of all crime.  <b>Risk Analysis:</b>            Not achieved target  <b>Interventions Recommended:</b>            A Violent Crime Profile has been produced and this will assist in deploying resources in Q1 until the 2007 Strategic Assessment has been produced.  <b>Interventions/Projects Current:</b>            The Streetsafe Project was a major intervention which sought to reduce violent crime in Oldham, especially in the town centre. Consideration is currently being given to continuing the initiative in 2007/2008. Positive action in respect of Domestic Violence incidents will continue. A MORI survey is currently being undertaken to identify gaps in provision for victims of DV.</p>	<p><b>Responsibility - Colin Cooper</b>  <b>Comments on Performance:</b>            Whilst the comments at Q2 are still valid in relation to the National Recording Standards, the Borough has seen a reduction in the number of violence against the person offences in Q3 and the general trend is downward. Further analysis shows that during Q3 on average 26% of violence against the person offences were domestic abuse related and reflects the positive action by GMP at DV incidents. Violence against the person offences now accounts for 19% of all crime compared to 15% in 2005/2006.  <b>Risk Analysis:</b> Given the way that VAP figures are calculated it is unlikely that we will achieve our LAA target with a projected figure of over 2800 offences against a target of 1970.  <b>Interventions Recommended:</b> A Violent Crime Profile is currently being undertaken and this will assist in our understanding of the impact of the National Recording Standards on the figures.  <b>Interventions/Projects Current:</b> The Streetsafe Project is the major intervention which seeks to reduce violent crime in Oldham, especially in the town centre. The interventions linked to this project will feature as part of the violent crime profile.</p>

Analysis of the rise suggests that this is due to an increase in damage other offences which has exceeded the combined reductions in damage to dwellings and damage to vehicles. Overall the major reason for not achieving our target has been the 30% increase in damage to motor vehicles in the last twelve months.  <b>Risk Analysis:</b>            Target not achieved  <b>Interventions Recommended:</b>            A criminal damage profile has been produced and this will assist in targeting resources. Criminal Damage has now been incorporated within the Property Crime Taskforce with a dedicated champion and delivery plan.  <b>Interventions/Projects Current:</b>            Whilst previously there have been a number of ad hoc projects via Area Action Teams, there is now a dedicated action plan and delivery champion. Projects to tackle criminal damage offences are still being worked up.</p>	<p><b>Responsibility - Colin Cooper</b>  <b>Comments on Performance:</b> Q3 has seen a substantial rise in criminal damage offences compared to Q2, and now accounts for 38% of all comparator crime, with damage to a motor vehicle accounting for over 50% of offences.  <b>Risk Analysis:</b> The current projection is that we will not achieve our target with a projection of over 6500 offences compared to a target of 5624.  <b>Interventions Recommended:</b> A Criminal Damage profile is currently being undertaken to give the partnership a better understanding of the issues surrounding criminal damage. Further analysis shows that during Q4 on average 25% of violence against the person offences (VAP) were domestic abuse related and reflects the positive action by GMP at DV incidents. Analysis of the the data suggests that a high percentage of offences in all four priority areas are those involving criminal damage offences, especially to vehicles, assaults, theft from motor vehicles and burglary. GMP have adopted the National Crime Recording Standards. It is unknown at this time whether this has significantly contributed to the increase in comparator crime. Although it is suspected that this has indeed effected the number of assault offences contained within the figures. As can be seen Medlock Vale is showing in relation to performance whilst Alexandria is off track.  <b>Risk Analysis:</b> Even though there has been a significant reduction in the number of comparator crimes in Quarter Two, the current performance would suggest that, except for Medlock Vale, it is highly unlikely that we will achieve our target for the year.  <b>Interventions Recommended:</b> To commission a number of thematic profiles around criminal damage and violence against the person offences to compliment those profiles currently being produced around vehicle crime and burglary. This work will concentrate in the main on the priority areas where 30% of all crime occurs. Following the analysis, action plans will be prepared to target resources in these areas.  <b>Interventions/Projects Current:</b> A number of interventions are currently taking in the priority areas through the work of the Area Action Teams. Evaluation of these interventions will assist when the thematic and geographic profiles are produced.
