Making the Best Use of Oldham's Housing Stock

Introduction

The Housing Block of the Oldham Partnership has been awarded some Neighbourhood Renewal Fund money and is seeking to commission a piece of research activity to explore the causes, perceptions and impact of overcrowding and under occupancy in Oldham.

Census figures from 2001 show that Oldham has the second highest level of overcrowding in Greater Manchester and the fifth highest level of under occupancy. There is however little evidence available on the causes, perceptions and impact of overcrowding and under occupancy in Oldham. Primary research will seek to explore these issues and identify stakeholder and resident views on potential solutions. The results of this research will contribute to the development of an Overcrowding and Under Occupancy Policy for Oldham and feed into the development of Oldham's Local Area Agreement and link to the key priorities of the Housing Strategy.

The activity will be steered by a group, comprising representatives from Oldham Council's Housing Strategy Team, Adult and Community Services Information and Research Team, Housing Market Renewal Team and the Commissioning Unit.

The outcomes of the research will contribute to the provision of information to support the following LAA indicators and targets for the Housing Block:

Objectives	<p>The research will explore:</p> <ul style="list-style-type: none"> • Perceptions of overcrowding and under occupancy amongst stakeholders and Oldham residents • Perceived causes of overcrowding and under occupancy amongst stakeholders and Oldham residents • Perceived barriers to tackling overcrowding and under occupancy in Oldham • Potential opportunities for tackling overcrowding and under occupancy in Oldham • The impact of overcrowding/ under occupancy standards
Target groups/ sample	<p>The research will include:</p> <ul style="list-style-type: none"> • Participants from areas of Oldham known to have high levels of overcrowding (e.g. Coldhurst, St Mary's and Alexandra) • Participants from areas of Oldham known to have high levels of under occupancy (e.g. Medlock Vale, Alexandra, St Mary's, Saddleworth West & Lees and other areas with pockets of high under occupancy levels) • Participants from all tenure groups regarding overcrowding • A particular focus on the views of social housing tenants regarding under occupancy • Participants from a range of property sizes and types • A representative sample across key demographic groups including age, gender, ethnicity and disability • Participation from key stakeholders

Additional requirements	<p>Suggested Methodologies</p> <p>It is envisaged that the research will take a qualitative approach and will incorporate the following methodologies:</p> <ul style="list-style-type: none"> • One to one semi-structured interviews • Focus group discussions

Agencies/ consultants must make proposals as to how these methodologies would be used to meet the objectives of the research. This should include identification of proposed sample sizes to meet the requirements of the activity.

Agencies/ consultants will be expected to submit a detailed proposal for recruiting participants from a range of tenures and demographic groups which is cost effective and meets the objectives and time constraints of the activity.

Considerations for Submitted Proposals

- Alternative methodologies that can work with different budgets
- Suggestions for any additional objectives
- Analysis and report structure taking into consideration how the findings will be used to make comparisons between different variables
- Proposal must show examples of similar work carried out with references
- Suggestion on how the steering group will be kept informed throughout the activity
- Any quantitative data will need to be held in a way which is compatible with MS Excel
- Pricing structure detailed in a way which clearly shows alternatives and prices for the individual aspects of the work
- Costs for briefing and debriefing sessions with presentation of findings including at least 1 progress meeting near the end of the activity and 10 colour reports
- Feedback mechanisms to those consulted

The successful delivery agent will be expected to liaise and share information with any other agencies/consultants also selected for the other commissioned activity listed on the Oldham Partnership website funded through the Local Area Agreement.
