Councillor Jean Stretton Leader, Oldham Council

Jean Stretton became Oldham Council Leader on January 27, 2016 and had served as Deputy Leader since 2014. In June 2016, she took on the Fairness, Equalities and Cohesion portfolio in the Greater Manchester Combined Authority (GMCA) following the devolution of more powers from Central Government. Cllr Stretton's remit includes the Inclusive Growth agenda.

Amongst her other duties, Councillor Stretton is chair of Oldham Credit Union. On governing bodies at both Oasis Academy and Limehurst Primary and has served on the Contour Estate Board since 2003. She is also a keen supporter of Oldham Foodbank.
